Janna's teaching and research interests encompass constitutional and administrative law, Aboriginal law, colonial legal history,

Indigenous—settler relations and treaties, Indigenous law, and legal pluralism. She has published on Aboriginal administrative law, treaty relationships and interpretation, and the historical development of intersocietal law between Indigenous and European fur traders.
