

**BIOGRAPHY / BIOGRAPHIE****Tim Moseley**

Tim is Chief Adjudicator of the Capital Markets Tribunal, an independent division of the Ontario Securities Commission. He was a full-time Vice-Chair of the OSC, and chair of its Adjudicative Committee, until becoming Chief Adjudicator of the newly created tribunal in early 2022.

Tim has been involved for many years with the Society of Ontario Adjudicators and Regulators (SOAR) Certificate in Adjudication course, and the Advanced Certificate course, both co-presented by Osgoode Professional Development, as a faculty member and volunteer coach, and formerly as a co-Program Director and Hearing Simulation Director. He has taught evidence-related topics and decision writing.

Prior to his appointment to the OSC in 2015, Tim was CIBC's Chief Compliance Officer for over ten years, following two years as Head of the Litigation Group (Canada) in CIBC's Legal Department. Before that he practiced corporate/commercial litigation for twelve years, including six years in private practice, and six years as

Litigation Counsel in the OSC's Enforcement Branch, with the last two of those years as Manager of Litigation. Tim holds a B.A. and an LL.B. from the University of Toronto, an M.B.A. from Queen's University, and the ICD.D designation from the Institute of Corporate Directors, through the Rotman School of Management at the University of Toronto. He was called to the Ontario bar in 1989.

Tim is Co-Chair of the Laskin Moot Court Competition, which annually considers problems involving administrative and constitutional law.

Tim Moseley a occupé le poste de vice-président de la Commission des valeurs mobilières de l'Ontario (CVMO) de 2017 à 2022. Auparavant, il a été président du comité d'arbitrage de la Commission. Il a été aussi membre de la Commission à temps partiel de 2015 à 2017.

Avant d'enrichir les rangs de la CVMO, M. Moseley a occupé le poste de responsable mondial de la conformité au sein de la CIBC pendant plus de dix ans après avoir occupé celui de chef du Groupe canadien du contentieux au sein du Service juridique de la société. Avant cela, il a pratiqué le litige commercial et corporatif pendant douze ans, dont six en pratique privée et six à titre d'avocat du contentieux à la Direction de l'application de la loi de la CVMO où, au cours des deux dernières années, il a occupé le poste de chef du contentieux.

Il est coprésident du concours de plaidoirie en droit « Laskin », qui examine chaque année des questions touchant le droit administratif et constitutionnel. Il est également membre du conseil d'administration des Dixon Hall Neighbourhood Services, une agence de services sociaux intégrés desservant surtout les résidents de l'est du centre-ville de Toronto.
